The Lessee agrees to use the premises in a careful manner and to reimburse the Lessor for any damage due to his occupancy of said space. The Lessee must have an absorbent pad under the motor and transmission - NOT PLASTIC! Battery must be disconnected. No locks on your hitch.

The Lessor does not assume, nor is responsible for any damage to the property of the Lessee caused by fire, water, theft, or vandalism, or from any other cause while in the said building or on the Fairgrounds. The Lessee hereby assumes responsibility for any losses caused by fire, water, theft, or vandalism, or from any other cause and hereby releases the Lessor from any liability for such damage. The Lessee is responsible for any damage caused to any other vehicles or property during parking of vehicle. LESSOR is NOT RESPONSIBLE FOR ANY DAMAGE INCURRED WHEN YOU ARE PARKING or REMOVING YOUR VEHICLE.

## 2024 Winter Storage Rates

Vehicles may be stored starting <u>approximately</u> October 1st and must be removed within 10 days of notification in the spring. <u>We will call when you are to remove your vehicle(s)</u>. An additional fee of \$50.00 will be charged for vehicles not removed within 10 days with a \$10.00 charge for each day thereafter. The only exception would be prior arrangement made with the Board of Directors . If any questions, please call the Fair Office at 724-654-7745 or 724-510-7412.

Rates are charged on the length of the vehicle and location of the storage space. Inside storage is in an enclosed, locked building; outside storage is in a building with open sides. The length is measured from bumper to bumper, hitch to bumper, or hitch to rear of boat or motor.

Owners rent storage space at their own risk and are advised to continue their insurance, to remove small articles, and to use locking gas caps. Owners should prepare the vehicles or boats for storage BEFORE bringing them to the Fairgrounds. This includes cleaning, draining lines, removing batteries, etc. Blocks need to be placed under the tongue to prevent wheels from rolling. Adequate absorbent material must be placed under motors that may leak.
